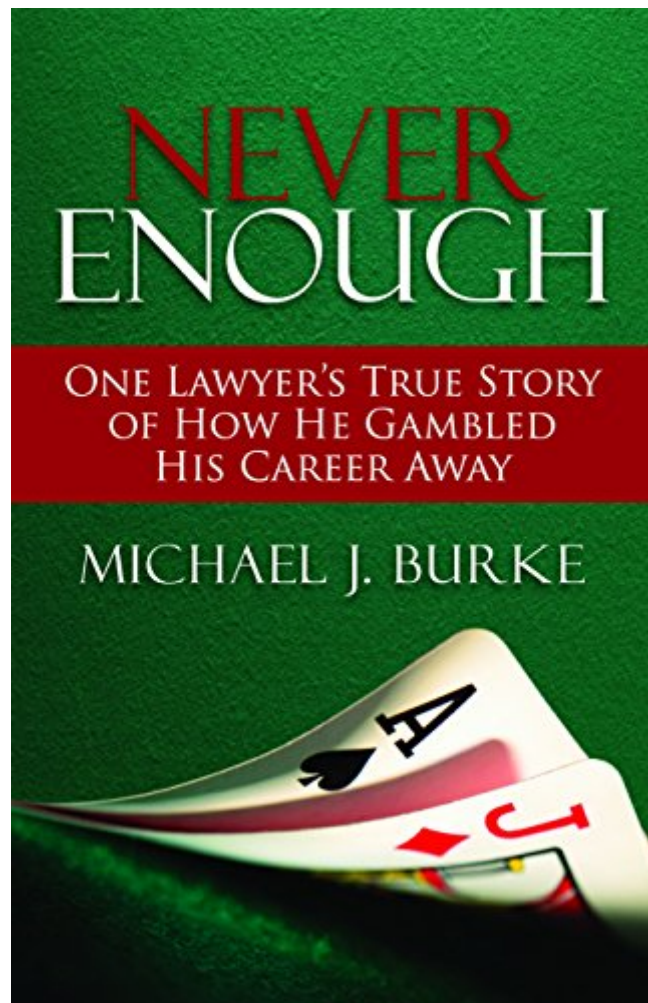

This is a well written story of a professional man who is also a compulsive gambler. My issues with the story is that at a short 138 pages (says the book is 250 pages but there are only 104 pages of story and 34 more pages of index, etc.)I feel lots of important details were left out, such as explaining the breaking point the author reached which caused him to turn himself in. Also, the author states that one of the reasons he wrote the book was to try to raise some restitution money for the embezzlement victims, which might possibly explain the list price of \$29.95 for a 138 page paperback book.

I wasn't searching for this particular book or any addition related books in . Encountered it by chance and got interested after reading the reviews. I received it yesterday by mail and read it all in a couple of hours. Some good things about the book. 1. It is composed of only 100 pages, small and crisp. 2. It is a real life story. 3.
