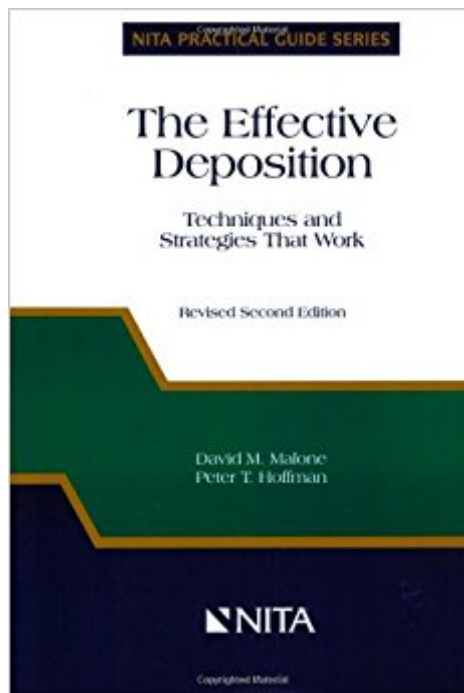

Since many states still follow the pre-1993 version of the Federal Rules concerning discovery, the practice under the pre-1993 version is examined as well.
